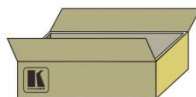
101L Quick Start Guide

Step 1: Check what's in the box

- ✓ 101L Video Line Amplifier
- ✓ 1 Power supply (12V DC)

- ✓ 4 Rubber feet
- ✓ 1 Quick Start sheet



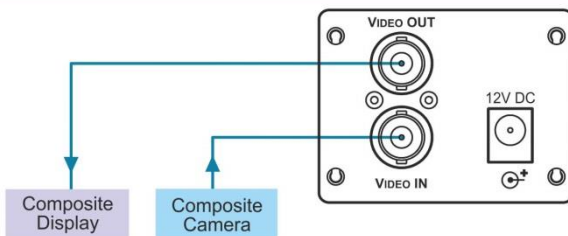
Save the original box and packaging materials in case you need to return your **101L** for service.

Step 2: Install the 101L

Attach the rubber feet and place on a table or mount the **101L** in a rack (using an optional **RK-1** rack mount).

Step 3: Connect the inputs and outputs

Always switch off the power on each device before connecting it to your **101L**.



Always use Kramer high-performance cables for connecting AV equipment to the **101L**.

Step 4: Connect the power

Connect the 12V DC power adapter to the **101L** and plug the adapter into the mains electricity.



Step 5: Operate the 101L

If needed, adjust the equalization and level.

2.1 Achieving the Best Performance

To achieve the best performance:

- Use only good quality connection cables (we recommend Kramer high-performance, high-resolution cables) to avoid interference, deterioration in signal quality due to poor matching, and elevated noise levels (often associated with low quality cables)
- Do not secure the cables in tight bundles or roll the slack into tight coils
- Avoid interference from neighboring electrical appliances that may adversely influence signal quality
- Position your Kramer **101L** away from moisture, excessive sunlight and dust



This equipment is to be used only inside a building. It may only be connected to other equipment that is installed inside a building.

2.2 Safety Instructions



Caution: There are no operator serviceable parts inside the unit

Warning: Use only the Kramer Electronics input power wall adapter that is provided with the unit

Warning: Disconnect the power and unplug the unit from the wall before installing

3 Overview

The high performance **101L Video Line Amplifier** is used for amplifying the video signal intensity and improving the image sharpness (the picture quality) when a video signal is transmitted over a long cable.

In particular, the **101L** features:

- Extra-wide bandwidth of 500MHz
- Gain and equalization trimmer controls to compensate for signal losses inherent in long cable runs, recessed to prevent tampering

3.1 Defining the 101L Video Line Amplifier

This section defines the **101L**.

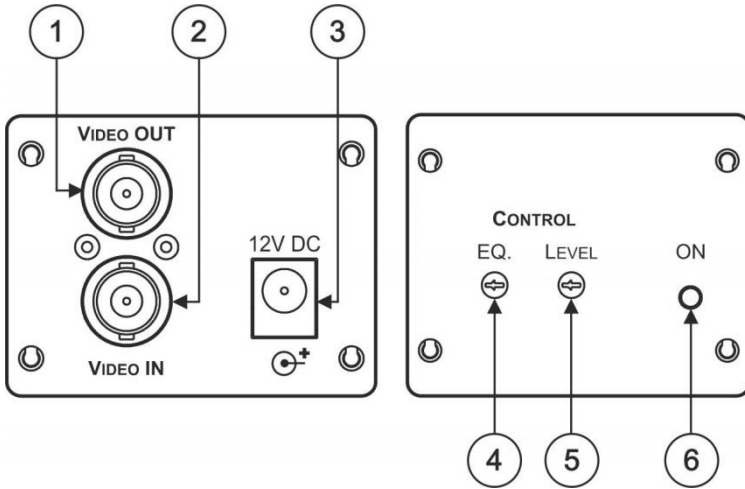


Figure 1: 101L Video Line Amplifier

| # | Feature | Function |
|---|-------------------------|---|
| 1 | VIDEO OUT BNC Connector | Connects to a video acceptor |
| 2 | VIDEO IN BNC Connector | Connects to the video source |
| 3 | 12V DC | +12V DC connector for powering the unit |
| 4 | CONTROL EQ. Trimmer | Adjusts the cable compensation equalization level |
| 5 | CONTROL LEVEL Trimmer | Adjusts the output signal level |
| 6 | ON LED | Illuminates when receiving power |

4 Connecting the 101L



Always switch off the power to each device before connecting it to your **101L**. After connecting your **101L**, connect its power and then switch on the power to each device.

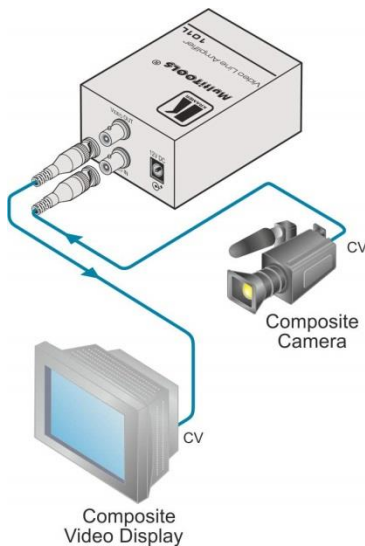


Figure 2: Connecting the 101L Video Line Amplifier

To connect the **101L**, as illustrated in the example in [Figure 2](#), do the following:

1. Connect the video source (for example, a composite video camera) to the VIDEO IN BNC connector.
It is recommended that you connect the 101L closer to the source than to the acceptor.
2. Connect the VIDEO OUT BNC connector to a video acceptor (for example, a composite display).
3. Connect the 12V DC power adapter to the power socket on the **101L**, and connect the adapter to the mains electricity.
The ON LED illuminates.
4. If required, adjust the output signal level (LEVEL) and/or cable compensation equalization level (EQ.) with a small screwdriver.
